The envelope should be super scribed “**TENDER FOR SALE OF 100 MT PER HOUR CAPACITY SALT WASHERY AT MVSC, VALINOKKAM IN RAMANATHAPURAM DISTRICT**” Tender due on 22.03.2024 Offer should be submitted by the tenderer in Appendix-II (Part-2) enclosed duly filled in with a covering letter in their own printed letter head containing GST Registration No. or other proof of the tenderers firm, office location and full address. Offer will be summarily rejected if proof of tenderers existence is not furnished.
4. Tender will be accepted up to 3.00 P.M. on 22.03.2024 only at **TAMIL NADU SALT CORPORATION LTD, LLA BUILDING, 4th FLOOR 735, ANNA SALT CHENNAI-600 002**. The tender will be **opened at 3.30 P.M on the same day** in the presence of tenderers. Tenders received after the due date and time will not be accepted.
5. The Salt Washery offered for sale as per this tender will be sold on **AS IS WHERE IS** basis only in a **single lot**.

INSPECTION

6. After purchasing the tender documents, tenderers will be allowed to inspect the Salt Washery at our Project on any working day between 10.00 A.M. to 5.00 P.M and up to 21.03.2024 with prior permission from the Project Manager.
7. Tenderers are requested to go through the terms and conditions of the tender carefully before quoting the rate.

RATE

8. **The minimum upset value fixed for the offer is Rs.90 lakhs.**
9. Tenderer should quote their rates clearly both in words and figures without any ambiguity. Vague offers such as offers in lot / size/average etc., will not be accepted and such offers will be summarily rejected. In case of variation of rates quoted in figures and words the highest rate in these two will only be considered.
10. Tenderer shall quote the rate in ink or ball pen (not with erasable pencil) clearly both in words and figures without any ambiguity and exclusive of tax, freight, freight tax, loading etc. GST will be added wherever applicable to arrive at the total rate at the time of delivery. Rate quoted should be for the unit given in the tender. Vague offers such as offers in lot/size/average etc will not be accepted and such offers will be summarily rejected. In case of any variation in rates quoted in figures and words, the higher rate of these two will only be considered.
11. No fax/telex/telegraph/electronic mail quotation will be accepted.
12. Incomplete tender submitted with either qualifying conditions or with conditions at variance with general terms and conditions are liable to be rejected summarily.
13. Conditional and combined offers/quotations/tenders are liable to be rejected.

VALIDITY

14. Validity of the offer should be kept open for a period of 30 days from the date of opening of tender.

15. Tender should be accompanied with demand draft towards Tender schedule cost for an amount **Rs.15000/- exclusive 18% GST. Hence the DD shall be drawn to the total amount of Rs.17,700/-**. The tender cost is non-refundable.

EARNEST MONEY DEPOSIT (EMD) FOR TENDER PARTICIPATION

16. Tender should be accompanied with a demand draft towards EMD for an amount of **Rs.3,00,000/-** (Rupees three lakhs only)
17. EMD should be remitted by means of Demand Draft **in favour of “Tamilnadu Salt Corporation Limited payable at Chennai”** drawn on any Nationalized Bank.
18. Offer bid along with proof of eligibility and EMD should be submitted by 22.03.2024 up to 3.00 PM at Corporate Office, Chennai.

TENDER DUE DATE

QUALITY AND QUANTITY

19. The Salt washery available in the project will be sold on **AS IS WHERE IS** basis in so far as the physical condition and quality is concerned, that is to say, tenderers will be deemed to have been aware of the physical condition and quality by inspecting the material before submitting the tender and no complaint in this regard will be entertained by Tamil Nadu Salt Corporation after the submission of tender or participation in auction.
20. TNSC reserves the right to withdraw from sale, the material offered for sale in full **or part thereof** prior to or after the acceptance of the tender, without assigning any reason whatsoever.

TENDER OPENING

21. Immediately upon receipt of tenders, the tenders will be opened at 3.30 P.M. 22.03.2024 in the presence of the Tender Committee and details of eligible tenderers and price bids noted. Tenderers who fail to meet the requirements of eligibility will be informed at the spot at the time of opening. All tenderers are therefore required to be present at the time of opening of tenders by themselves or through a properly authorized agent with written authorization and identification proof.

SIGNATURE OF THE TENDERER

22. The EMD amount remitted by the successful tenderer will be retained till the completion of the work.
23. The EMD will be refunded to all the unsuccessful tender participants except the H1 and H2 tenderers immediately after the Tender is over. H2's EMD will be retained for **Fifteen days** beyond the time limit fixed for H1 to complete payment for salt washery bid. EMD will not bear any interest. The Salt washery offered for sale is being sold on AS IS WHERE IS basis.
24. The tenderer may inspect the condemned & old buildings before quoting the rate. Once rates are quoted, any excuse of not seeing the scrap will not be allowed. After the sale order, the tenderer should remove the items from the places where they are stored at their own cost and arrangement as per the time prescribed by the Corporation.

25. PAYMENT TERMS

The successful H1 tendered shall remit 100% payment, in one single Installment within 10 days from date of sale order.

26. DEFAULT IN PAYMENT BY THE BUYER

In case of any default in payment within the time limits specified above, the bidders' EMD shall be forfeited. In case both H1 and H2 default, the Corporation reserves its right to forfeit EMD of both H1 and H2 and to offer Salt Washery to other tenderers or other buyers at mutually acceptable rates.

27. CLEARANCE

The successful tenderer after remitting the full value of the material should arrange to lift the materials within 30 days from the date of payment.

28. DEFAULT IN LIFTING BY THE BUYER

If the tenderer fails to lift the material as stipulated above, the Corporation will charge penalty at 2^{1/2} % per week on the value of the material to be lifted or part thereof subject to a maximum of 5%.

SIGNATURE OF THE TENDERER

29. ACCEPTANCE OF BID

Upon completion of tender, the Corporation will advise the successful tender participant on the same day about the bid acceptance or otherwise. The Corporation reserves the right to accept or reject any or all the tenders/auction without assigning any reason whatsoever and no correspondence will be entertained in this regard. Fixation of upset price is only for the use of the Corporation and the decision on acceptance/rejection of tender or auction price bid is entirely at the discretion of the Corporation.

30. LIFTING OF MATERIAL

The responsibility of loading the parts of salt washery into the trucks lies with the successful tenderer only. Corporation will not bear any expenses towards the sale.

31. RIGHT OF WITHDRAWAL

The Corporation reserves the right to withdraw this offer for sale of Salt washery at any time in the sales process until contract finalization without any notice or by furnishing any reasons therefor. In such a case, all offers received are automatically cancelled and bids or EMD will be refunded immediately.

32. GENERAL

- a. The price quoted once cannot be withdrawn or reduced.
- b. Tenders containing over written or erased rates are liable to be rejected. Ink or ball pen should be used to record price.
- c. The intending tenderers may obtain any clarification well before tendering.
- d. Submission of tender implies that the tenderer has obtained all the clarifications required and that they have agreed to all terms and conditions herein specified.
- e. The decision of the Managing Director in TNSC in any matter arising out of this sale shall be final in regard to all matters relating to this contract.
- f. All kinds of legal proceedings in any matter arising out of this contract shall be liable only with appropriate Civil Court at Chennai.

SIGNATURE OF THE TENDERER

33. DISPUTE

a. If during the continuance of contract / agreement or during any extended period of contract / agreement or at any time afterwards, any dispute arise between the parties hereto in regard to the construction of any of the articles herein contained or relating to any other matter of thing to be made or done in pursuance hereof or to any other matter or a thing relating to performance of said contract agreement or extension thereof, such disputes shall be forthwith referred to arbitration. The Managing Director of the Tamil Nadu Salt Corporation Ltd., will be the Sole Arbitrator. The said arbitration shall be held at Chennai, Tamil Nadu only.

b. The courts in the City of Chennai shall be deemed to be the Courts of jurisdiction in respect of any claim dispute etc. arising out of this agreement.

34. FORCE MAJEURE :

TNSC shall not be liable for any failure or delay in performance due to any reasons / causes beyond their control including fires, floods, go slow, lock out, closure, dispute with staff, dislocation of normal working conditions, war, riots, epidemics, political upheavals, government action, civil commotion, break down of machinery, shortage of labour acts demands or otherwise or any other cause or conditions beyond the control of aforesaid cause or not and the existence of such cause of consequence may operate at the sole discretion of TNSC to extend the time of performance on the part of TNSC by such period may be necessary / to be necessary to enable TNSC to effect performance after the cause of delay will have ceased to exist. The provisions aforesaid shall not be limited or abrogated by any other terms of contract whether printed or written.

35. Tenderers must ensure the following while submitting the tender.
